SUBJECT: Minutes of VBMA Regularly Scheduled Meeting Held on 18 March 2014

1. Meeting called to order at 4:07 PM by Jeff Davis. The VBMA Secretary Chris Heagy was not available, so Jeff took meeting notes in his place. This meeting was held on the 3rd Tuesday of the month, at the 40 et 8, Vancouver, WA.
